From the Desk of the President

Dear Friends and Supporters,

Your unwavering support and generosity have been instrumental in advancing our mission and achieving significant milestones this year. I am pleased to share some of the highlights of our journey in the financial year 2023-24. This year presented both challenges and achievements.

We are proud to report that our outreach across all programs continued to remain strong. Highlights include 386 eligible children from our Palna WeeKids



program entering regular schools, 376 girls from the Vocational training program passing the NSDC exam, and 825 children receiving educational sponsorship. In March, we joyously resumed our tradition of Palna Day. It was a festive celebration with 70 of our Palna children and their forever families, marking our first gathering in four years since the pandemic.

Amid our efforts to maintain full capacity and high-quality programs, our largest centre in Janakpuri serving around 200 beneficiaries has been declared unsafe due to extensive structural damage. Following a thorough technical evaluation, the Executive Committee decided it would be safer to demolish and rebuild it. This setback has been the most significant since our founding in 1952. Our goal is to complete reconstruction within the next 18 months. Meanwhile, we have minimised disruption by relocating programs to a nearby rental facility, ensuring continued support for our beneficiaries.

Going forward, our primary focus remains on rebuilding the Janakpuri centre. In addition, we are working on opening new centres as also expanding programs in existing centres. Focus continues on enhancing our trainers' skills and improving our internal MIS. We are currently undertaking a major project to digitise our Palna records dating back to 1978. In January, we successfully soft-opened the Shahbad Dairy centre, which is gaining momentum. We are also pursuing strategic long-term funding arrangements for our programs.

We were honoured by a visit from Chief Justice of India Dr. D Y Chandrachud and Justice Yashwant Verma, underscoring our mission's importance. We also honored Assistant Directors Ms. Lorraine Campos for 35 years and Mr. Sanjay Kumar Mishra for 30 years of devoted service. Our heartfelt thanks to the entire DCCW team for their unwavering commitment to providing over 2500 under privileged children with a brighter future every day.

Thank you all for your support, and we rely on your continued help through the challenges ahead.

PALNA Adoption Programme

(Established 1978)

Palna – meaning both *cradle* and *nurture* in Hindi - is our home and adoption centre for abandoned, displaced and lost children. It is located in the Civil Lines area of Delhi and was established in the year 1978. We prefer calling it a home rather than an institution, as that is what we aim for. It continues to be our flagship programme and touches the soul of individuals who visit us. At any point of time Palna is a home to 70 to 75 children. Over the years Palna has placed over 3000 children to their forever homes through the process of legal adoption. The families who adopt are selected after a rigorous screening and an evaluation process.

Majority of the children that we receive come to us through the cradle placed at the gate, which allows anyone to place children in it anonymously. Children are also brought by the police. Occasionally, families do come to relinquish their child.





The infants and toddlers usually arrive in a precarious state of health: low birth weight, hypothermic, children with trauma congenital defects / diseases. Their fragile condition requires immediate medical intervention which is ably offered by our round the clock medical team comprising a Senior Consultant on call, resident doctor, nurses, para-medical staff and caregivers. We also have access to hospitals that are in the vicinity for emergencies.

Palna's emphasis is towards addressing all aspects of child's development – health, nutrition, safety and protection, physical, social, emotional and psychological - which is a paramount part for the overall growth of the child. Palna has full time professional social workers, a counsellor, special educator and a teacher to enable the overall development of all the children. We have an informal pre-school education inhouse while older children go to nearby schools.

All these initiatives have ensured that our children do not have the milestone delays typically associated with children in institutions – strengthening our claim that Palna is a home, not an institution!

Palna Bal Chetna: Over the years Palna has been receiving an increasing number of children with profound disabilities – both mental and physical. We have a separate

unit within the home called Bal Chetna which serves these children. They require constant medical monitoring along with intensive physiotherapy, tailored nutrition and care. There is a large number with cerebral palsy, and several others have autism, and various other congenital syndromes and physical disabilities. It is only rarely that we have succeeded in placing such children in adoption. Palna focuses on making their lives as comfortable as possible, while also working on helping them achieve their physical and mental potential.

This year in focus

- **103 children** were resident at Palna through this year, of which 31 were new arrivals
- Since the pandemic, the adoption processes have slowed down. This year only 9 Palna children joined their adoptive families, which is close to half of the previous year, and almost a third of the pre-pandemic norm. As a result, more children have been resident in Palna all through this year.
- The percentage of special needs children is at an all-time high, being close to 50 percent.
- 10 children were restored to the biological parents.
- In a first, older Palna children went to regular schools in the neighbourhood in alignment with government guidelines.
- The pre-school programme running in-house was enhanced to cover a wider age group.
- **PALNA Day**, an annual tradition at Palna for decades, was held after a gap of 4 years after being suspended during the pandemic. It is an evening when children who started out in Palna come back with their families to spend an evening of fun together. We saw more than 70 children and their families get together at Palna!
- Apart from Palna Day, we had many Palna children now adults! from India and across the world visit to reconnect with their first home. They all supported Palna in various ways during their visits.
- An emergency ramp was constructed with the support of Celebi Delhi Cargo Terminal Management India Pvt. Ltd.
- Rotary Midwest Trust supported a much-needed laundry unit at Palna.
- Palna was honoured to host several notable **well-wishers**, including:
 - o Honourable Chief Justice of India Dr. D. Y. Chandrachud and Justice Yashwant Varma along with their families spent an afternoon with the Palna children.
 - Australian Deputy High Commissioner Nicholas McCaffrey and Mr. Andrew Charlton MP, Australia.






The other was a baby who arrived as month-old infant with a critical congenital heart defect which required her to be on oxygen constantly in the 2 months at Palna, she expired before the planned surgery was possible. Both expired in hospitals.

SHELDON: A heartening tale of adoption

Sheldon (name changed) arrived at Palna through the cradle at our gate, as a newborn 1-day old infant.in October 2021. As he was of low birth weight and looked ill, he was taken to our Medical Crisis Unit, to be examined by the doctor. As he showed respiratory distress he was immediately hospitalised. Investigations showed that the baby had congenital acyanotic heart disease with a slightly enlarged heart and a hole between the upper chambers of the heart. He had broadband rockers bottom feet, was dysmorphic with his head being slightly big for his size.



After being stabilised he was discharged, and came back to Palna, where he was under intensive medical care in the nursery isolation unit, and on a special diet.

After a period of six months 2D Echocardiography was repeated and it was found that the hole in the heart had closed and structurally the child now had a normal heart.

In January 2023 the child's motor functioning was however found moderately delayed. With the help of physiotherapy management & early stimulation he overcame these delays, and soon started walking independently. Despite all the challenges, little Sheldon was a strong and determined child. His charming smile easily won the hearts of everyone around him.

Finally, we decided to try and find an adoptive family for him, though we knew it would be difficult given his medical issues. It took a while but finally in December 2023 a young family from the United States of America accepted and took our little Sheldon as their own. We are grateful and feel blessed to have found a wonderful family willing to accept Sheldon despite his medical issues. It is so rare that this happens.

Vocational Training Programme

(Established 1976)

The **Vocational Training Programme** (VTP) aims to equip underprivileged adolescent girls, - mostly school dropouts from underprivileged families living in the slums / resettlement colonies of Delhi - with income-generating skills. The courses offered focus on home-based vocations requiring minimal investment. Post-completion of the training, the girls also receive guidance on sourcing raw materials and marketing their products.

The courses offered are beauty culture, tailoring and computers (Basic, Advanced & Tally). The programme operates at 14 centres in Delhi and has been attracting an increasing number of young participants annually. All our Vocational training courses are affiliated to the National Skill Development Council (NSDC), which greatly increases the value of the courses for all the trainees.



This year in focus

- There were **967 beneficiaries** across all courses this year
- **376 trainees** who successfully completed the National Skill Development Council course and cleared the exam with flying colours were awarded their certificates.
- A generous donation from Mr Ramit Budhraja and family have enabled us to start a **new unit for computer training** at our Qudsia Bagh premises.
- Capacity-building sessions for our VTP instructors were organised. Subject matter specialists conducted refresher courses to enhance the skills of our instructors.

- Eye check-up camps were held at all centres in January 2024 in association with the India Vision Institute. 325 girls received free spectacles.
- A ten-day self-defence training course was conducted in November covering 120 girls across four centres with the support of the Delhi Police (Special Police Unit for Women and Children) Nanakpura.
- The ICICI Foundation organised financial literacy sessions in July/August 2023 for 550 vocational training participants. The girls were also informed about government schemes run by the government for the benefit of girls and women.
- In December a cancer screening camp was organised at our Madipur centre in collaboration with CanSupport and Rajiv Gandhi Cancer Hospital.
- Partner organisations also conducted sessions on menstrual and personal hygiene, and balanced nutrition at several of our centres.
- Institute of Management Technology team conducted informative sessions on skill development, financial literacy, and market linkages.
- Diwali Melas were organised at all centres in October where the girls showcased their skills in mehndi and rangoli making, and sold products like candles, diyas, cosmetics and toys that they had made. These events engage the community and highlight the girls' efforts.
- Educational tours were organised for VTP girls in November and December. A total of 255 girls participated in these trips and enjoyed the outings.

NISHA: Determined to succeed

Nisha is a young woman who joined our Vocational training Programme in beauty culture in 2016, as a step towards achieving her dream of becoming an independent woman and owning her own salon. She lost her mother just after she had completed her schooling, and lived at home with her father and brothers. While doing the course itself



she started working in a small way from her home to start earning. She eventually topped her training course! Soon after she started working at a nearby salon and was earning well. But as the only woman in the house, she had many responsibilities at

home, and so she started freelancing and working from her home, while also pursuing a graduation.

Recently, when DCCW needed an instructor for beauty culture at one of our centres, her name was recommended and she was interviewed, and made an offer. Her family approved of the job considering a secure and conducive work environment and so she happily accepted. Alongside, she is pursuing her Masters in Arts, while also doing very well as an instructor!

Educational Sponsorship Programme

(Established 1979)

The Educational Sponsorship Programme seeks to encourage the parents from lower income groups to send their children to school and to have them stay in school by providing financial support, coaching, and career counselling to the children.

Girls, children with disabilities, and children from single-parent households are given preference. The financial assistance that we provide is sponsored by individuals and organisations to cover the extra expenses of transportation, school supplies, books, and uniforms for children enrolled in school. A quarterly stipend is provided as support, and the academic progress of the children is also monitored.






This year in focus

- **825 children** benefited from this initiative, as compared to 791 last years.
- This year we have registered **many new beneficiaries**, taking into account those who completed school and have therefore moved out of this scheme.
- After the dip during the pandemic, when many beneficiaries dropped out, we are on the path to strengthen this initiative.
- **Career counselling** was organised for class-VIII to Class-XII students.
- Eye checkups for children between the age group of 10 to 18 years was organised in collaboration of India Vision Institute. Spectacles were given to those children with poor eye vision.
- Along with the stipend and counselling, the children also received stationery and an annual gift.
- A **one-time financial assistance support** was given to 11 students who scored an outstanding 80% and above in 12th board exam, to help them pursue further studies.

 Ms Valentina Pitton and Ms Varinia Merlino from International Action, Italy, who support 250 students in our Educational Sponsorship Programme visited our Trilokpuri and Madipur centres.

PAYAL: Towards A Brighter Future

Payal joined the Educational Sponsorship Programme when she was studying in the Class VIII. Her father works as an electrician in a private company and earns Rs. 12,000/- monthly, while her mother is a housemaker. Payal is the oldest child and she has two younger siblings, who are schoolgoing. Her father is not in good health but the family is solely dependent on his income.

Determined to excel academically, Payal utilised the programme's benefits to the full, paying her school fees, attending tuition classes, and making the most of the annual gifts.



Her dedication to academics paid off when she achieved an impressive 80% in her 12th grade board exams. Payal's hard work and determination led her to clear the Common University Entrance Test (CUET), securing a seat at the prestigious Gargi College in Delhi, where she is now pursuing her B. Com degree. In parallel, she is also preparing for the Institute of Banking Personnel Selection examination.

DCCW helped her in pursuing her determination to educate herself further to help her in getting a career, by giving her a one-time financial assistance of Rs. 30,000/-.

Payal's ultimate goal is to fulfil her father's dream of seeing her become an educated, financially secure, successful woman. We wish her all the best for her future.

PALNA WeeKids

(Established 2019)

The **PALNA WeeKids** (PWK) initiative, launched in April 2019, aims to prepare young, underprivileged children in the age group 2½ to 6 years for mainstream schools. We operate out of 14 centers across various slum and resettlement areas of Delhi, with each unit catering to 30-35 children. This year the program had **913 beneficiaries, which is more than a 50% increase over last year**.

The objectives of the programme are to equip pre-school children for the structured environment of formal schooling by enhancing their language and numeracy skills, as well as promoting social and motor skills and overall physical health. For many, this is their first experience of a classroom-like setting, where they learn basic skills. Each unit consists of a trained teacher and a helper, and is equipped facilities and materials for art & craft, clay modelling, music, yoga, and audio-visual corners. A comprehensive monthly syllabus emphasising practical knowledge, analytical skills and holistic development is followed.






Our centers also guide parents through the school admission process, advising them on necessary documents and helping them prepare for admission interviews. Parentteacher meetings are held regularly.

This year in focus

- The programme had a total 913 children this year and was run in 14 centres.
- Almost 90% of the children eligible for regular schooling have successfully gained admission into mainstream schools, including reputed schools like St. Xavier's, Nav Jeevan Public School and Sarvodaya Vidyalaya.
- There were dropouts during the year, mainly due to migration of the parents
- Pending **critical repair and maintenance** was carried out at various centres with support from Turner Group and Mrs. Sadhna Alstrom.
- EXL sponsored uniforms for all the beneficiaries across all centres.
- Ujjivan Small Finance Bank sponsored school bags for 125 beneficiaries.

- A one-day refresher training and orientation program for all Instructors was conducted by Mr. Senapati from National Institute of Public Cooperation and Child Development.
- Monthly parent teacher sessions included discussions on school admissions, required formalities, and addressing children's issues.
- A team of experts from Tirath Ram Shah Charitable Hospital conducted screenings and assessments of the PWK children at our Trilokpuri centres. Parents of beneficiaries attended counselling sessions on symptoms and diagnosis of behavioral issues.
- Older kids from the units at Madipur, Qudsia Bagh, and Trilokpuri 1 & 2 centers were taken on an excursion to the Dolls Museum and Bal Bhawan.
- Festivals and national days were celebrated at all centres.

BHAVYA: Following in her father's footsteps

Bhavya was admitted to our PWK programme at Trilokpuri in July 2022, when she was 2.5 years old. Interestingly, her father, who currently works in a small company, had been a beneficiary of our erstwhile creche programme many years ago, and so was aware of the dedication of the staff as well as the services being provided by DCCW. He had earlier enrolled his son in Palna WeeKids, and now his daughter, Bhavya.



Bhavya enjoyed coming to the centre, and participated in every activity. She did well at academics too and could write Hindi and English alphabets as well as recognise numbers. After two years at the centre, her parents' initiative bore results and she got admission into Upadhyay Public School, New Ashok Nagar, Delhi.

The parents have shown their gratitude towards the organisation by supporting us with farewell gifts for the children during the farewell ceremony, at which Bhavya also performed a beautiful Rajasthani dance! We do hope she excels in school as well!

Supervised Homework Scheme

(Established 1958)

Our Supervised Homework Scheme (SHS) provides essential academic assistance to children from low-income families, studying in Classes I–VIII. The program aims to enhance academic performance and reduce school dropout rates by offering homework support and tutoring.

During the 2023-2024 academic year, a total of **285 children** attended the Supervised Homework Scheme across all our centres in Delhi. All our children were promoted to their next classes. Students excelling academically and whose parents have limited financial capacity are integrated into our Educational Sponsorship Programme.





Instructors are evaluated annually and are assigned classes based on their capabilities. The progress of students is monitored through their school report cards, which helps in assessing the qualitative inputs of instructors on a centre-wise basis. Regular monthly tests are conducted to track the students' progress.


To promote holistic development, the program includes recreational activities and brain-stimulating sessions every Saturday. These activities include imparting general knowledge, puzzles, games, fostering reading habits, moral stories, newspaper reading, and nature walks.

This year in focus

- This year there has been a focus on **enhancing both the quality and the reach** of the programme.
- The programme had **285 beneficiaries** across all our centres.
- All our children were promoted to their next classes in school.
- Written and viva evaluations of all the instructors was carried out.
- A training session was also conducted by our Palna Counsellor for all instructors.
- A total of 43 parent-teacher sessions were held across all the centres.
- In collaboration with India Vision Institute, eye check-ups and awareness camps were held at all centers in January 2023.

- Mahindra and Mahindra Group marked their Founder's Day by distributing backpacks and stationery to some of our SHS children.
- SGTB Khalsa College students performed an entertaining "*nukkad natak*" on healthy eating for the children.
- Institute of Management Technology team engaged the Supervised Homework Scheme students in activities focused on life skills, health awareness, sanitisation, child sexual abuse prevention, and community development.
- Children were taken on educational excursions within the city.


MANSHI: Embodiment of positivity

Manshi, joined our Supervised Homework Scheme at the New Seemapuri centre in 2022 when she was in Class VI. She belongs to a family that migrated from Uttar Pradesh to Delhi in search of better opportunities. The father works as a roadside tailor, and is the sole breadwinner. Her mother expired in 2023 due to illness. Manshi has three siblings.

When she joined our centre, Manshi was good in languages but found mathematics as well as fluency in reading very difficult. Over the last two years she has shown great improvement, and stood 2nd in her Class VII examinations scoring 80% marks.

Manshi is also a keen participant in all the co-curricular activities conducted at the centre, her school and in the

community. She dances well and has also bagged a prize for football in matches organised in the community.



We hope she continues to go forward with the same zest and enthusiasm!



Bal Chetna Day-Care Programme

(Established 2002)

Our **Bal Chetna day-care programme** provides day-care and rehabilitation to special needs children belonging to underprivileged families of Delhi. The idea of starting this programme in 2002 came from the fact that a growing number of such children were being abandoned at Palna. The objective of the programme is to make each child as self-reliant, competent, and communicative as possible, within his/her constraints, and helping the families in providing holistic care to the children, and not abandon them. As per their individual needs, the children receive special education, speech therapy and physiotherapy sessions from professionals at our centre.

After being suspended in March 2020 due to the pandemic, the programme was restarted in January 2023 at our Janakpuri centre. Through this year the programme has been running very successfully and at full strength. We hope to start one more Bal Chetna day-care centre in the coming year.






This year in focus

- This year there has been a focus on making this programme fully operational at our Janakpuri centre, with all therapeutic and other facilities.
- We had **35 children enrolled** in the programme through the year, which is our maximum capacity for one centre.
- Along with necessary rehab therapies, children are also provided with **supplementary nutrition** which includes egg, milk, biscuits and seasonal fruits.
- A doctor performed weekly medical check-ups.
- Development plans and reports are maintained for each child. Almost every child enrolled in the programme has shown improvement.
- Four of our Bal Chetna children have started going to school.
- Supporting the family of the child has been an area of focus, with home visits by the staff and **programs for parents**.
- The children showcased their talent and stole hearts at an event hosted by Concern India Foundation.
- In December 2023, Bal Chetna Day / World Disabled Day was marked with special activities for the children. All festivals and national days were celebrated.

KARTIK: Striving towards his potential

Kartik is a five-year-old special needs boy diagnosed with Global Developmental Delay which is a form of development delay in which child is not able to achieve cognitive, motor and language milestones. He enrolled in Bal Chetna programme in

the month of January 2023 with difficulty in maintaining sitting balance and inability to stand. He was also not able to speak properly, or hold things like a pencil in his hands.

At our Bal Chetna centre he has been undergoing physiotherapy; speech therapy and special education sessions regularly. Soon the impact could be seen as he was able to sit properly and started to speak in monosyllables. In July 2023, during a medical check-up at the centre he was diagnosed with seizure disorder, and was started on a regimen of medication and nutritional care.



With proper care and appropriate and regular rehabilitation therapies, he is now able to stand and start walking a few steps without any support. He is also able to express himself by speaking short sentences and can identify fruits and count numbers. It is amazing to see how much he has progressed in just over a year!

Construction of our Janakpuri Centre building

As mentioned in last year's annual report, our flagship Janakpuri centre had to be closed in March 2023 due to structural issues in the building. After detailed assessments by experts, it was concluded that it would be better - both in terms of cost and quality - to demolish the existing structure and construct a new building, as versus trying to strengthen the existing structure.

An architect has been identified for this project and plans for the new building have been drawn up and submitted for approval. The contract for the demolition of the building was given in January, and the work started in February 2024. It is expected to complete in three months, after which the construction will be started.

This is the biggest setback we have had both operationally and financially since DCCW was established in 1952, and we will need assistance from all our well-wishers towards getting this accomplished.

Status update on Centres

In October 2023 we had to take a decision to close down our centres in Karala and Nithari as the community environment made it untenable to carry on our daily operations due to various reasons.

We opened a new centre in the Shahbad Dairy area in January 2024. The centre has units of Palna WeeKids, Supervised Homework Scheme and Vocational training in Beauty culture and Tailoring running, and is now running at good strength.

Critical repairs that were necessary at three of our centres were undertaken on a priority basis, with support from a couple of our long-standing partners. There are still several more that need to be urgently undertaken in the coming year.

Annual General Body Meeting:

The Annual General Body Meeting for the year 2022-23 was held on September 29, 2023 at the DCCW head office. The Annual Report for the year was presented at the meeting by Ms Radhika Minocha, Hony President, and the annual audited accounts were summarised by Mr Ishwinder Singh, Hony Treasurer. Hony General Secretary, Mr Asheesh Vaderaa discussed the massive challenges that lie ahead due to the Janakpuri centre having to be rebuilt, and the overall need for funds for our programmes.
